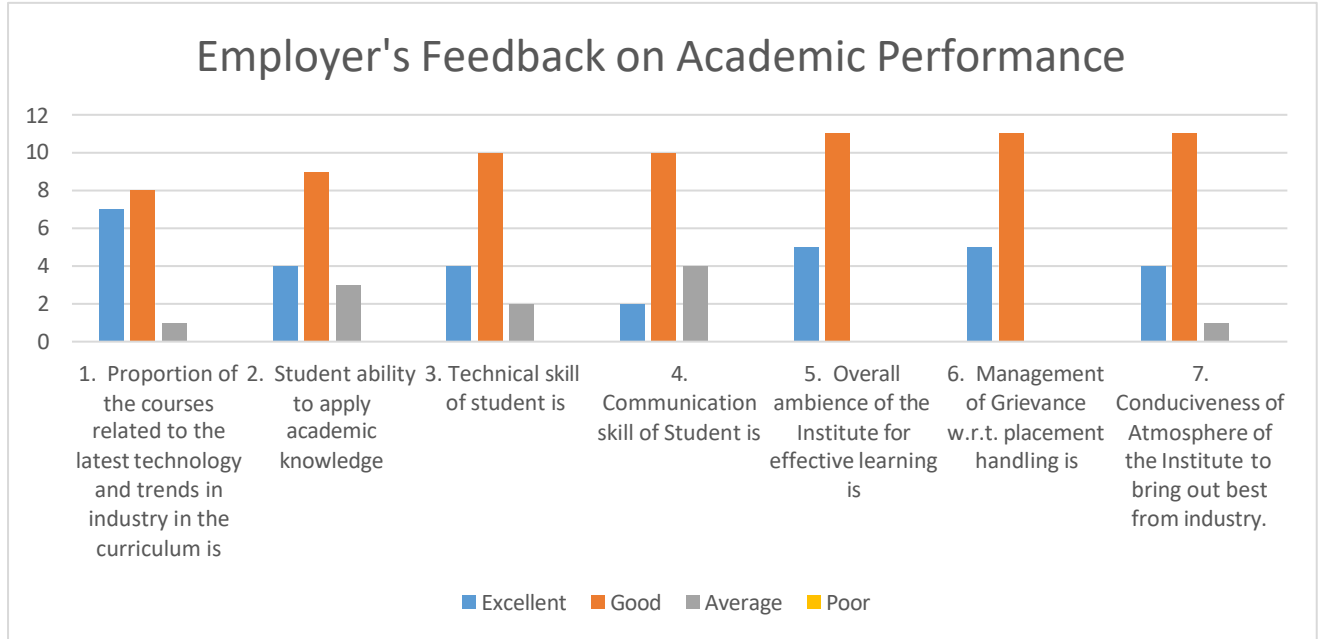

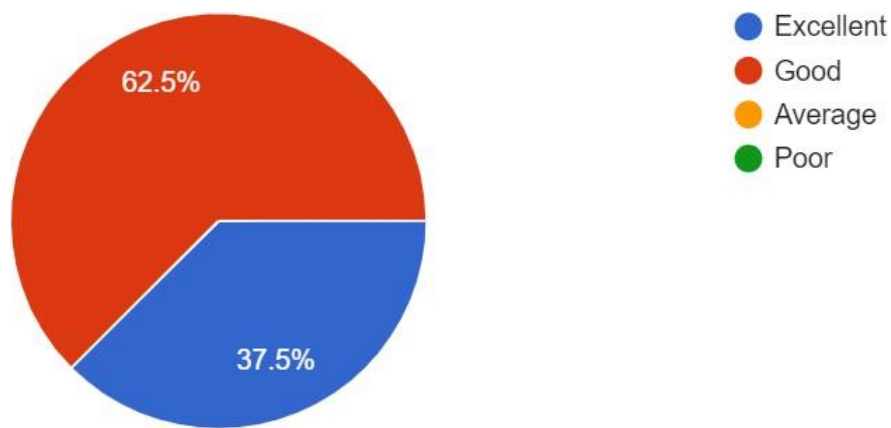

1. Employer Feedback – Academic Performance

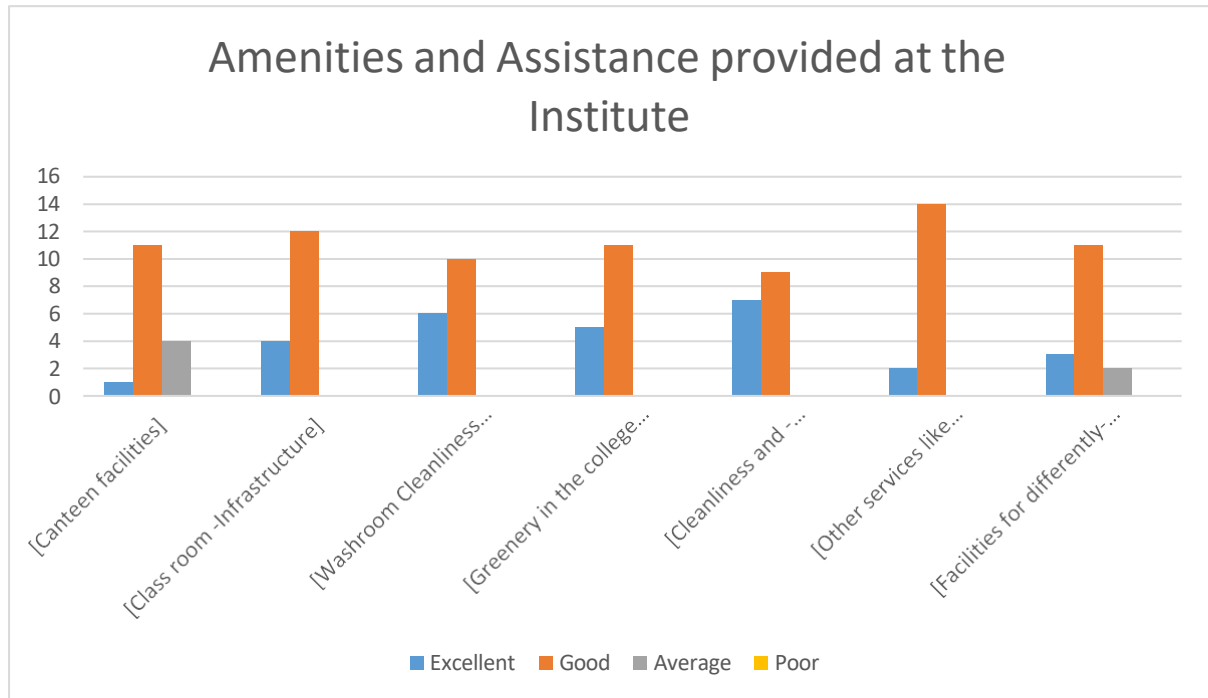
